

**Title: Director of Health Policy**

**Position Summary**

The Kenny Guinn Center for Policy Priorities (“Guinn Center”) is a nonprofit (501c3), independent (bipartisan) policy research center focused on delivering relevant, fact-based and well-reasoned analysis of critical policy issues that advance solutions toward a vibrant Nevada and Intermountain West region. The Director of Health Policy is charged with leading all research on Federal, state, and local health policies (e.g., Medicaid, behavioral health, access, social determinants, addiction), and for contributing to a full range of outreach and engagement tactics. The Director of Health Policy is charged with building a research program and policy agenda that informs current public debates about health policies in Nevada and the region. The Director of Health Policy is responsible for conducting rapid-response and long-term analysis of data and programs, as well as developing and writing policy papers and testimonies of various lengths and formats for a variety of audiences. The ideal candidate is a self-starter (with nonprofit experience) with demonstrated success in leading and managing qualitative and quantitative research projects, organizing public outreach activities, and communicating effectively to a broad audience.

**Primary Responsibilities**

**1. Research and Analysis**

- Develop and execute a project plan and agenda for evaluating and analyzing relevant health policies that affect Nevada and the Intermountain West region (including Medicaid, workforce, access, social determinants of health)
- Serve as the Guinn Center’s institutional expert on health policy.
- Analyze emerging public policy issues and trends and produce Guinn Center policy publications including issue briefs, white papers, conference papers, presentations, and testimony, using primary and secondary research sources.
- Lead and participate in coalitions of experts and advocates on health policies.
- Represent the Guinn Center in high-visibility forums, including meetings with elected officials, policymakers, issue experts & stakeholders, national conferences, and the media.

**2. Public engagement and outreach**

- Manage existing and build new relationships with community partners.
- Help plan and organize events to share Guinn Center research.
- Help plan and manage working groups across many stakeholders.
- Support development efforts by drafting concept papers, letters of intent, proposals, reports, and all other necessary fundraising-related documents along with senior leadership.

### 3. Grants & Contract Management

- Be knowledgeable about current grant and contract obligations, reporting requirements and reporting formats and templates, and work with staff to ensure those obligations and reporting requirements are met.
- Help maintain database of current and prospective funders.
- Help prepare narratives and financial reports to foundations and other funders as needed.

### Qualifications

The ideal candidate will possess the following skills and experience:

- Graduate degree in relevant field.
- Five years' experience analyzing public policies
- Working knowledge of health policies (access, disparities, workforce, behavioral health, etc.)
- Extensive and strong writing ability, including developing and writing articles, studies, reports, or other publicly available documents.
- Ability to conduct research using qualitative and quantitative methods (e.g., ability to run multivariate regression using STATA is a plus).
- Self-starter with significant experience working in non-profit environment.
- Strategic thinker who has the ability to build programming and public engagement activities.
- Outstanding project management skills suited to a dynamic work environment with multiple ongoing responsibilities, tight deadlines, and expectations for high-quality work.
- Experience communicating policy ideas in public settings such as coalition meetings, legislative hearings, conferences, and with the media.
- Results-oriented leader with a track record of senior-level success leading and securing resources for policy organizations.
- Ability to work collaboratively with staff and board.
- Highly-organized, attentive to detail, goal-oriented, and capable of multi-tasking.
- Strong leader with ability to work independently with minimum direction.
- Ability to think independently and uphold the (politically) independent nature of the organization.
- Flexibility for occasional travel (limited to Nevada and the Intermountain West region)
